This office represents former Stoughton Police Officer David M. Cohen, with respect to the issue described herein. A review of payroll information which you recently supplied to Mr. Cohen shows that he was not paid for the following items:

- 1. At least 87 accrued vacation days;
- 2. At least 144 hours of comp time accrued for not using sick time;
- 3. At least 152 hours of supervisor comp time;
- 4. At least 125 unused sick days;
- 5. At least 481 hours of overtime for court attendance in my case;
- 6. At least 280 hours of overtime for court preparation in my case;
- 7. At least 61% of the educational incentive pay due me for 2007, and;
- 8. At least 61% of other accrued stipends and benefits.
